

LOUISIANA BOARD OF MASSAGE THERAPY

IN THE MATTER OF

APPLICATION FOR LICENSURE OF NICOLE TAYLOR

CONSENT AGREEMENT AND ORDER

WHEREAS, NICOLE TAYLOR (“Ms. Taylor”) submitted her application for licensure with the Louisiana Board of Massage Therapy (“LBMT” or the “Board”) on or about May 27, 2025 and is subject to the jurisdiction and rules and regulations of the LBMT;

WHEREAS, in connection with her application for licensure, information was disclosed to the Board that Ms. Taylor has a prior conviction for possession of drug paraphernalia in violation of La. R.S. 40:1023 on October 13, 2016, in the 17th Judicial District Court for the Parish of Lafourche;

WHEREAS, the information provided also revealed that Ms. Taylor has a conviction for possession of drug paraphernalia in violation of La. R.S. 40:1023 on September 4, 2024, in the 17th Judicial District Court for the Parish of Lafourche and was sentenced to one-year unsupervised probation;

WHEREAS, Ms. Taylor has indicated her desire to resolve this matter through a Consent Agreement and Order provided for in LAC 46:XLIV §5901 and La. R.S. 49:975(D) of the Louisiana Administrative Procedure Act;

WHEREAS, Ms. Taylor recognizes her right to have an administrative adjudication of the charges outlined in this Consent Agreement and Order, at which time Ms. Taylor would be entitled to be represented by legal counsel, to call witnesses, and to present witnesses on her behalf in defense or in mitigation of the charges made, and to a decision thereon by the Board based upon

written findings of fact and conclusions of law in accordance with the Louisiana Administrative Procedure Act. Ms. Taylor nonetheless waives her right to formal adjudication and, pursuant to La. R.S. 49:975(D), consents to the entry of the Consent Agreement and Order set forth hereinafter. Ms. Taylor also acknowledges that she waives any rights to which she may be entitled pursuant to the Louisiana Administrative Procedure Act, La R.S. 49:951, *et. seq.*, or which she otherwise may be afforded by any law, to contest her agreement to, or the force and effect of this Consent Agreement and Order, in any Court or other forum.

IT IS HEREBY ORDERED that in consideration of the foregoing and pursuant to the authority vested in the Board by La R.S. 49:975(D), the Board orders that the application for licensure of Nicole Taylor is hereby granted subject to the following conditions to protect public health and safety until the completion of her probation:

1. Ms. Taylor shall provide the Louisiana Board of Massage Therapy ("Board") monthly reports showing compliance with the terms of her unsupervised probation imposed by the 17th Judicial District Court;
2. Ms. Taylor shall provide the Board with a copy of every document issued by the 17th Judicial District Court regarding any change in the status of probation immediately following receipt of said document;
3. Ms. Taylor's license shall be placed on probation until she successfully completes her unsupervised probation, at which time she shall provide documentation of the completion of her criminal probation and disposition of her case to the LBMT for review. During the period of probation, Ms. Taylor must comply with all terms of her probation. Ms. Taylor shall remain on probation until receipt by Ms. Taylor of correspondence from the LBMT stating that she is released from probation.

4. Failure to abide by the foregoing conditions or with the terms of her unsupervised probation imposed by the 17th Judicial District Court shall be sufficient grounds to summarily suspend her license; and
5. By agreeing to the terms of this Consent Agreement and Order, Ms. Taylor waives all rights to appeal this adjudication.

Effect of Non-Acceptance of Agreement. Ms. Taylor acknowledges that this Consent Agreement and Order is subject to the approval of the Board. She further acknowledges and agrees that if the Board rejects this Consent Agreement and Order, it will be void, and a hearing on the application of Ms. Taylor relative to the allegations contained herein may proceed. If this Consent Agreement and Order is rejected by the Board, it will not constitute a waiver of Ms. Taylor's right to a hearing on the matters alleged in this Consent Agreement and Order will have no effect. Ms. Taylor further agrees that if the Board rejects this Consent Agreement and Order, the members of the Board may decide the matter after a hearing, and their consideration of this Consent Agreement and Order shall not alone be grounds for recusal of any member of the Board, including any claims that the Board is biased against them, that it cannot fairly decide the case, or that it has received *ex parte* communication.

IT IS HEREBY FURTHER ORDERED that this Consent Agreement and Order shall take effect immediately upon its adoption by the Board and is a public record of the Board. The terms of this Consent Agreement and Order shall be published and reported in, including but not limited to, the LBMT website.

THIS CONSENT AGREEMENT AND ORDER shall take effect immediately upon adoption by the Board and is a matter of public record.

I, **JAMES R. RAINES**, serving as Prosecutor, do hereby acknowledge negotiation and preparation of this Consent Agreement and Order in order to resolve, with prejudice, the

application for licensure of Nicole Taylor, and further certify that this Consent Agreement and Order is consistent with the evidence, adequately addresses the allegations of the Consent Agreement and Order, and represents a true and correct statement of that which could be proven at a hearing of this matter.

I expressly acknowledge that the disclosure of such information to the LBMT shall be without prejudice to the Prosecutor's authority to prosecute any issues raised in the Consent Agreement and Order, or the LBMT's capacity to adjudicate the allegations raised in the Consent Agreement and Order, should the LBMT decline to approve this Consent Agreement and Order. I further acknowledge my awareness that should the LBMT approve this Consent Agreement and Order that the Consent Agreement and Order will become a matter of public record.


