VOLUNTARY SURRENDER OF LICENSE

WHEREAS, NORMAN NAIL ("MR. NAIL") is a lapsed Licensed Massage Therapist, and is subject to the jurisdiction and rules and regulations of the Louisiana Massage Therapists and Massage Establishments Act (La. R.S. 37:3551, et seq.), and the rules promulgated by the Louisiana Board of Massage Therapy ("LBMT") (LAC 46:XLIV §101, et seq.);

WHEREAS, the LBMT received a complaint by J.F.

WHEREAS, due to an arrest of MR. NAIL and pending criminal lawsuit against him, the LBMT and MR. NAIL, through counsel, agreed to postpone a hearing in the above referenced proceeding;

WHEREAS, Mr. Nail plead guilty to one count of sexual battery and one count of misdemeanor sexual battery on December 8, 2021;

WHEREAS, the respondent, NORMAN NAIL, has indicated his desire to voluntarily surrender his license with the LBMT, particularly License No. 0458;

WHEREAS, the respondent, NORMAN NAIL, acknowledges that in accordance with the written policies of the LBMT, the following will result due to the voluntary surrender of his license;

1. A report of this Voluntary Surrender of License and the conditions under which his license was surrendered shall be submitted to the National Practitioners Data Bank ("NPDB").
2. Public notification of this Voluntary Surrender of License by posting a copy of this Voluntary Surrender of License on the LBMT website.
3. He shall be ineligible for reinstatement of his license to practice as a massage therapist in the state of Louisiana.

WHEREAS, MR. NAIL acknowledges that he has had the opportunity to thoroughly review the contents of this Voluntary Surrender of License and that he is informed of and understands his rights, including his rights to due process in connection with this Voluntary Surrender of License.;


WHEREAS, MR. NAIL acknowledges, stipulates and agrees that as a result of the voluntary surrender of his license, and the allegations against him, he shall be ineligible for reinstatement of his license to practice as a massage therapist in the state of Louisiana;

WHEREAS, by the voluntary surrender of his license, MR. NAIL, moreover, acknowledges, stipulates, and agrees that he hereby waives any right to which he may be entitled pursuant to the Louisiana Administrative Procedure Act or which otherwise may be afforded to him by law, to contest his agreement to, or the force and effect of this document in any Court related to the matters referred to herein, and further waives the right to appeal the acceptance and approval of this Agreement by the LBMT;

WHEREAS, MR. NAIL acknowledges that he has had the opportunity to seek the advice and guidance of legal counsel with respect to this Voluntary Surrender of License;


WHEREAS, based upon the above, NORMAN NAIL surrenders his license held with the LBMT, particularly License No. 0458.
