RE: Massage Therapy Establishment License

To Whom It May Concern,

During the Louisiana Board of Massage Therapy Board Meeting held on October 16, 2020, the Board discussed that all schools which offer massage therapy services to the public as part of student training, which requires an establishment license, going forward, will be included in the list of licensed establishments which are subject to periodic routine compliance inspections. After the discussions, the Board voted that all schools with an establishment license will be subject to the same standards that apply to any business providing massage therapy services to the public.

Inspections will check for compliance with the Rules as outlined in Title 46. Chapters 25, 27, 29, 33 and 41. This information may be reviewed on the website (www.labmt.org) by selecting the "Louisiana Law" tab on the home page and then "Rules".
