CONSENT AGREEMENT AND ORDER

WHEREAS, TWO RED ACORNS INC. d/b/a ENJOY MASSAGE (“ENJOY MASSAGE”) is a licensed massage establishment in the State of Louisiana holding license number E3116;

WHEREAS, Jing Zhou (“Mr. Zhou”) is listed as the owner of ENJOY MASSAGE on its Louisiana Board of Massage Therapy (“LBMT”) establishment license renewal application;

WHEREAS, a female complainant reported to the LBMT that on or around February 15, 2025, during a massage therapy session provided by a male therapist, the pressure applied was “intense,” causing her to have “tears in her eyes.” She stated that the massage focused primarily on her shoulders, particularly over the bones, and that the therapist attempted to pull down her underwear to massage her buttocks, which she expressly instructed him not to do. The complainant further reported that she told the therapist “at least five times” that the pressure was too intense, but the therapist disregarded her requests. She indicated that she felt violated by the therapist’s conduct.

WHEREAS, Mr. Zhou, as owner of ENJOY MASSAGE, has indicated his desire to resolve this matter through a Consent Agreement and Order provided for in LAC 46:XLIV §5901 and La. R.S. 49:975(D) of the Louisiana Administrative Procedure Act;

WHEREAS, Mr. Zhou has admitted to the following:

1. Mr. Zhou is and was at all times pertinent to the facts and matters alleged herein the owner of ENJOY MASSAGE, a licensed massage establishment in the State of Louisiana which holds license number E3116 issued by the LBMT;

2. Mr. Zhou acknowledges that a former employee, Xiaotao Qin (“Mr. Qin”), who was not licensed by the LBMT, may have been involved in the incident that led to the complaint;
3. Mr. Zhou acknowledges that Mr. Qin was temporarily employed by ENJOY MASSAGE beginning on February 10, 2025, for several weeks;
4. Mr. Zhou acknowledges that ENJOY MASSAGE was not compliant with record keeping and did not have the records regarding the treatment of complainant;
5. Mr. Zhou acknowledges that allowing an unlicensed massage therapist to work at his massage establishment and failing to maintain proper records are violations of the following rules and regulations of the LBMT: La. R.S. 37:3558; La. R.S. 37:3563(A)(6)(7); LAC 46:XLIV §4101, and LAC 46:XLIV §5301(A)(8)(15);

WHEREAS, Mr. Zhou and ENJOY MASSAGE recognize their right to have an administrative adjudication of the charges outlined in the Order of Summary Suspension, at which time Mr. Zhou and ENJOY MASSAGE would be entitled to be represented by legal counsel, to call witnesses, and to present witnesses on their behalf in defense or in mitigation of the charges made, and to a decision thereon by the Board based upon written findings of fact and conclusions of law in accordance with the Louisiana Administrative Procedure Act. Mr. Zhou and ENJOY MASSAGE nonetheless waive their right to formal adjudication and, pursuant to La. R.S. 49:975(D), consent to the entry of the Consent Agreement and Order set forth hereinafter. Mr. Zhou and ENJOY MASSAGE also acknowledge that they waive any rights to which they may be entitled pursuant to the Louisiana Administrative Procedure Act, La R.S. 49:951, *et. seq.*, or which they otherwise may be afforded by any law, to contest their agreement to, or the force and effect of this Consent Agreement and Order, in any Court or other forum.

IT IS HEREBY ORDERED that in consideration of the foregoing and pursuant to the authority vested in the Board by La R.S. 49:975(D), the Board orders and Mr. Zhou and TWO RED ACORNS INC. d/b/a ENJOY MASSAGE accept the following administrative action, which is a final decision pursuant to La. R.S. 49:977:

1. License E3116 issued to ENJOY MASSAGE will be placed on probation for a period of one (1) year from the date that all parties sign this Consent Agreement and Order by the LBMT. During the period of probation, the establishment will be subject to three random inspections by the Board;
2. Mr. Zhou shall submit the name (and preferred name, if applicable) and contact information of the licensed massage therapist(s) working at ENJOY MASSAGE to the LBMT within fourteen (14) days that all parties sign this Consent Agreement and Order. The licensed massage therapist(s) will also be responsible for ensuring compliance with the Board's regulations and laws applicable to the practice of massage therapy in the State of Louisiana;
3. Mr. Zhou and ENJOY MASSAGE shall notify the LBMT in writing within seven (7) days of hiring a new massage therapist;
4. A licensed massage therapist must be present and available to provide services during all hours of operation;
5. If a licensed massage therapist is not available to work, ENJOY MASSAGE shall close until a licensed massage therapist is available to work;
6. Mr. Zhou and ENJOY MASSAGE shall provide the LBMT with a list of all non-licensed employees working at the establishment (and preferred name, if applicable).

Mr. Zhou and ENJOY MASSAGE shall notify the LBMT of any changes of the non-licensed staff within seven (7) days of such changes;

7. Mr. Zhou and ENJOY MASSAGE shall pay a fine and administrative costs in the amount of two thousand dollars and 00/100 (\$2,000.00), within thirty (30) days that all parties sign this Consent Agreement and Order, which payment shall be made by certified check or money order;
8. Mr. Zhou shall report the terms of this Consent Agreement and Order and its approval to any board and agency with which he is licensed, certified, or registered within five (5) business days of Board Approval of this Consent Agreement and Order;
9. Mr. Zhou and ENJOY MASSAGE specifically acknowledge that failure to comply with the terms of this Consent Agreement and Order may result in a denial, revocation, or suspension of any license, certificate, or registration issued by, or applied for, in accordance with LAC 46:XLIV §1701;
10. By agreeing to the terms of this Consent Agreement and Order, Mr. Zhou and ENJOY MASSAGE waive all rights to appeal this adjudication.

Effect of Non-Acceptance of Agreement. Mr. Zhou and ENJOY MASSAGE acknowledge that this Consent Agreement and Order is subject to the approval of the Board. They further acknowledge and agree that if the Board rejects this Consent Agreement and Order, it will be void, and a hearing on the application of ENJOY MASSAGE and Notice of Intent to Deny issued by the Board relative to the allegations contained herein may proceed. If this Consent Agreement and Order is rejected by the Board, it will not constitute a waiver of ENJOY MASSAGE's right to a hearing on the matters alleged in the Notice of Intent to Deny and the admissions contained herein will have no effect. Mr. Zhou and ENJOY MASSAGE further agree that if the Board rejects this Consent

I, Jing Zhou, make these acknowledgements and waivers in support of a final disposition of the pending investigation by Consent Agreement and Order ("Order") pursuant to La. R.S. 49:955(D), in lieu of the institution and prosecution of formal administrative proceedings, and accordingly consent to the entirety of the Order set forth hereinbefore and further waive any right to which I may be entitled under the Louisiana Administrative Procedure Act or any other law to contest, in any court, my agreement to this Order. By my subscription hereto, I also hereby authorize the Prosecutor to present this Order to the LBMT for its consideration and to disclose to and discuss with the LBMT the nature and results of the investigation of this matter. I herein waive any objection to such disclosure based on due process of law under either the State or Federal Constitution or under State statutory law, including La. R.S. 49:977.2, and further authorize the matter to be taken up in executive session by the Board, even in my absence. I expressly acknowledge that the disclosure of such information to the LBMT shall be without prejudice to the Prosecutor's authority to file a formal Administrative Complaint, or the LBMT's capacity to adjudicate such Administrative Complaint, should the LBMT decline to approve this Consent Agreement and Order. I further acknowledge my awareness that should the LBMT approve this Consent Agreement and Order that the Consent Agreement and Order will become a matter of public record.


