### **FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER**

Pursuant to La. R.S. 37:3555(A)(1), LAC 46:XLIV.6101 and the Louisiana Administrative Procedure Act, an administrative hearing was held before the Louisiana Board of Massage Therapy ("Board") on February 10, 2025, following the issuance of the Order of Summary Suspension on January 9, 2025 for License No. E3385 issued to Oriental Relax Massage, LLC to operate at 12240 Coursey Blvd., Suite K in Baton Rouge, Louisiana 70816 and License No. E3553 issued to Oriental Relax Massage, LLC to operate at 935 S. Morrisson Blvd. in Hammond and the issuance of the Order of Summary Suspension on January 9, 2025 for License No. LMT7795 issued to Guang Dong Bai.

Memry Hodum, Investigative Officer, was recused and did not participate in the hearing, deliberations or vote.

### **FINDINGS OF FACT**

1. ORIENTAL RELAX MASSAGE, LLC, License No. E3385 located at 12240 Coursey Blvd., Suite K in Baton Rouge ("RELAX-BR,") is owned by Yue Ying Jiang, Junjie Zhang, License No. LMT8683 Expired March 31, 2024 and GUANG DONG BAI, License No. LMT7795.
2. The Establishment License Renewal Application submitted for RELAX-BR indicates the phone number for the establishment is 225-228-2499.

3. ORIENTAL RELAX MASSAGE, LLC, License No. E3553 located at 935 S. Morrisson Blvd. in Hammond ("RELAX-HAMMOND") is owned by Yue Ying Jiang, Jun Jie Zhang, LMT8683 and GUAN DONG BAI, LMT7795.
4. The Establishment License Renewal Application submitted for RELAX-HAMMOND indicates the phone number for the establishment is 626-617-2836 and the fax number is 985-393-8469.
5. On January 9, 2025, an Order for Summary Suspension for License Nos. E3385 and E3553 was issued to ORIENTAL RELAX MASSAGE, LLC and set a hearing for February 10, 2025, (Board Exhibit, pp. 161-167). The Order of Summary Suspension was sent to ORIENTAL RELAX MASSAGE, LLC via email to [HNAQING888@YAHOO.COM](mailto:HNAQING888@YAHOO.COM), (Board Exhibit, p. 168), the email address listed on the application and sent by U.S. regular and Certified Mail No. 9589 0710 5270 2367 1643 54 to the address of record for RELAX-BR and was received by Guang Dong Bai and by Certified Mail No. 9589 0710 5270 2367 1645 14 to the address of record for RELAX-HAMMOND and was delivered on January 14, 2025 (Board Exhibit p. 169-170)
6. GUANG DONG BAI ("BAI), License No. LMT7795 is a licensed massage therapist who is listed as the Professional Therapist for ORIENTAL RELAX MASSAGE, LLC License No. E3385, located at 12240 Coursey Blvd., Suite K in Baton Rouge ("RELAX-BR,") and for ORIENTAL RELAX MASSAGE, LLC, License No. E3553 located at 935 S. Morrisson Blvd. in Hammond ("RELAX-HAMMOND"), (Board Exhibit, pp. 138-139 and 146-147) and to RELAX-BR.
7. BAI was the owner of ORIENTAL RELAX MASSAGE, LLC ("RELAX-GONZALES") located at 2325 Burnside Avenue in Gonzales prior to it being raided as part of a sting operation by the Gonzales Police Department on August 8, 2023. Following the arrest of the individual working at RELAX GONZALES for prostitution by massage and performing massage without licensure, RELAX-GONZALES closed and the license issued by the Board to RELAX GONZALES lapsed, (Board Exhibit, p. 312).
8. On January 30, 2025, a Board Inspector reported that RELAX-BR was closed, no lights were on and there appeared to be no activity on the premises; therefore, no inspection of the facility was completed, (Board Exhibit, pp. 105-112).
9. On January 30, 2025, a Board Inspector reported that at RELAX- HAMMOND:
  - A. There was no sign with the name of the establishment on the license.
  - B. When she arrived, the lights were off; however, the "open" sign turned on.
  - C. A woman opened the door and advised the business had been closed for some time.
  - D. The woman did not present an ID when asked.
  - E. The inspection was not completed because the woman was extremely upset.
  - F. Licenses were posted in the facility.
  - G. Prices for massages were posted in the facility.

- H. She delivered a Cease and Desist Notice advising the individual to “Cease and desist advertising and/or performing massage therapy services until any/all violations are cleared.” (Board Exhibit, p. 253).
10. The Board’s Inspector testified as follows:
- A. He searched the open web for the addresses, phone numbers and names as requested by the Board’s staff reviewed open source internet ads for GOOGLE by searching the owners’ phone numbers and businesses and user submitted reviews.
  - B. He observed advertisements with the phone number and address of RELAX-BR and RELAX-HAMMOND with pictorial representations of persons represented to be massage therapists attired and posed in manners to appeal to the prurient interests including on websites with restricted access including skipthegames.com, Pinkbodyrubs.com, eccie.net, adultfantasy.com and Harloithub.com marketing sexually oriented services including reviews of ORIENTAL RELAX MASSAGE indicating sexually oriented services were provided, (Board Exhibit, pp. 113-119, 131-137).

### **CONCLUSIONS OF LAW**

1. ORIENTAL RELAX MASSAGE violated:
- A. La. R.S. 37:3564(A) requiring, “[a]ny advertisement by a massage therapist or a massage establishment including but not limited to building signs, a website, and other promotional materials shall contain the name and number of the licensed therapist or establishment on file with the board.”
  - B. La. R.S. 37:3564(C) requiring “all pictorial representations for any advertisement representing massage therapy, including such representations through video, all persons representing massage therapists shall be attired and posed in a manner as to avoid appealing to the prurient interest.”
  - C. La. R.S. 37:3564(C) prohibiting licensed therapists and establishments from advertising “in any publication or any website marketing services appealing to the prurient interest.”
  - D. L.A.C. 46:XLIV.5301(A)(4) by “offering to engage a client in sexual activity.”
  - E. L.A.C. 46:XLIV.5301(A)(8) by violating rules of the Board.
2. La. R.S. 37:3558(D) prohibits licensure of a sexually oriented business as a massage establishment.

### **ORDER**

Considering the applicable law, testimony and the evidence;

IT IS ORDERED, ADJUDGED AND DECREED that License No. E3385 issued to ORIENTAL RELAX MASSAGE, LLC, to operate at 12240 Coursey Boulevard, Suite K, Baton Rouge, Louisiana 70816 is hereby REVOKED;

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that License No. E3553 issued to ORIENTAL RELAX MASSAGE, LLC, to operate at 935 S. Morrison Blvd. in Hammond is hereby REVOKED;

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that OREINTAL RELAX MASSAGE, LLC is fined \$1,000 for violating La. R.S. 37:3564(A) and \$1,000 for violating La. R.S. 37:3564(C);


IT IS FURTHER ORDERED, ADJUDGED AND DECREED that License No. LMT7795 issued to GUANG DONG BAI is fined \$1,000 for violating La. R.S. 37:3564(A) and \$1,000 for violating La. R.S. 37:3564(C) totaling \$2,000;

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that costs of this proceeding are assessed to ORIENTAL RELAX MASSAGE, LLC and GUANG DONG BAI; and

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that ORIENTAL RELAX MASSAGE, LLC and GUANG DONG BAI shall be ineligible for licensure by the Louisiana Board of Massage Therapy until the fines totaling \$4,000 and costs are paid in full.
